Member Referral Program

- Members may play Powderhorn Country Club, with cart, for an access fee of \$15. Play must be coordinated through the Legend Lake Golf Shop.
- Members may play St. Denis Golf Club, with cart, for an access fee of \$20. Play must be coordinated through the Legend Lake Golf Shop.
- Members are automatically enrolled in the GHIN System (the Golf Handicap and Information Network from the USGA) and as a NOGA member. With a NOGA membership, members are eligible to play in any NOGA sponsored events. (\$50 Value)
- Unlimited access to all practice facilities – driving range, putting greens, and short game practice area.
- "Fee-Free" Meeting Space. Members may entertain clients for small business meetings during peak months in our professional, private meeting room at any time.
